Dear Commissioner Vella,

Subject: The illegal trapping of migratory birds in Cyprus

BirdlLife, a global partnership of independent organisations, has published an article¹ about the huge practise of illegal trapping of migratory birds in Cyprus.

According to the article, in 2014 more than 2 million migratory birds were illegally trapped in Cyprus through 'mist' nets or so-called limesticks (birds feet got stuck in glue). The trapping of migratory birds has only one purpose: 'ambelopoulia', a local delicacy of Blackcaps or other tiny songbirds. Estimated, the trade in caught migratory birds would have resulted in a profit of 15 million euros a year, since a dozen birds can be sold for the price of 80 euros. Apart from catching 'profitable' birds, also other species got caught like swallows an owls.

In 1974 the government of Cyprus implemented a law which made the trapping of songbirds and migratory birds illegal, but in reality it did not result in a disappearance of the practice or the prosecution of poachers. The lack of effective measurements taken by the government of Cyprus is in conflict with the European law on the 'conservation of wild

birds 2 and the council directive of 2 April 1979 on the conservation of wild birds $(79/409/EC)^3$.

Is the Commission prepared to take actions against the government of Cyprus because of the lack of effective enforcement of the European law on conservation of wild birds? Has the Commission other methods to undertake action?

How will the Commission⁴ support the implementation of the Strategic Action Plan of BirdLife Cyprus, which is now in its final discussion? Will the Commission update its 'roadmap towards eliminating killing, trapping and trade of birds' in line with the findings mentioned in the Cypriote Strategic Action Plan?
